WHEREAS:

- 1) On the 8th January, 2025, **Nicholas Darville** ("the Applicant") filed a **Report of a Trade Dispute** against **Schooner Bay Ventures Ltd.** ("the Respondent") with The Department of Labour in Abaco, The Bahamas, which stated, inter alia, that the issues relevant to the dispute were: *Unfair & Unlawful firing/termination, Bribe of \$800.00 to avoid lieu of Notice & Severance pay, no contract during entire employment, no proof of investigation provided to Counsel and employee not given any opportunity to defend himself from allegations etc;*
- 2) By a **Certificate of Referral** dated the 13th June, 2025 (received on the 28th July, 2025), the Honourable Minister of Labour And The Public Service referred the said trade dispute to the Industrial Tribunal, Northern Region ("the Tribunal");
- 3) At 1:24 p.m. on the 31th July, 2025, The Tribunal's Clerk served the **Applicant** with a **Form A** (Originating Application) in accordance with **Rule 5(1)** of **The Industrial Relations Tribunal (Procedure) Rules, 2025** ("the said Rules") via Email sent to darvillenicholas@gmail.com;
- 4) The Applicant failed to file a **Form A** (Originating Application);
- 5) Pursuant to **Rule 22(1)** of the said Rules, the Tribunal permitted this matter to be set for Call Over to ensure that the case proceeds in a timely, efficient and just manner and to prevent undue delay or the accumulation of a backlog of cases;
- 6) The Tribunal served both parties with the Call Over date by substituted service, namely, the publication of a **Notice of Call Over** in **The Nassau Guardian Newspaper, Thursday, February 12th, 2025 Edition**, notifying both parties that this matter was set for Call Over before the Industrial Tribunal, Northern Region, The Bahamas, at 10:00 a.m. on Friday, 27th February, 2026; and
- 7) Both parties failed to appear before the Tribunal at 10:00 a.m. today, Friday, 27th February, 2026;

IT IS HEREBY ORDERED THAT this matter be dismissed pursuant to **Section 58(1)(d)** of **The Industrial Relations Act, Chapter 321**, as it appears to the Tribunal that further proceedings are unnecessary or undesirable in the public interest.
